II. REPORTS

- A. Financial John Pavka
 - 1. John gave the Financial report.
 - **2.** John summarized his discussion with the attorney regarding how to allocate the paving reserves. John and Jim will consult another attorney for their opinion on the matter.
- B. Management Lisa Deprez
 - 1. Lisa presented the Management Report. All items were in preparation for the annual meeting and are closed.

- A. Architectural Committee Kathy Clark, Terry Henry, Debbie Allison
 - 1. Kathy Clark is working to pull together the guidelines for the architectural committee. Lisa suggested that Anna Maria Wissinger might be interested in this committee.
 - 2. Kathy presented the arch committee report. 1 home currently approved for improvements.
- **B.** Landscaping Committee Steve Fickett/Jim Clark
 - 1. Jim wants to install sprinklers along the entrance road to try and keep those plants growing. Kathy made a **MOTION** to allow Jim to spend \$200 to install sprinklers along the entry road. Joe seconded the motion. Motion passed unanimously.
 - 2. There was a discussion about having US flags donated by residents to fly on the lighted trees along Foggy Ridge. The HOA would purchase the plaques. Larry is getting a quote on flags to see if the association can purchase. Tammy Merritt will get a price from Walmart where she is employed.
 - 3. Discussion about adding uplighting to more of the trees along Foggy Ridge. Jim to get a quote from Davis Electric for the lights.
- C. Inspections Committee Kathy Clark
 - 1. November Curb Appeal award: Earl & Phyllis McNair at 2223 Foggy Ridge Pky. December Curb Appeal award will be 24264 Twin Lakes Dr. Edger & Sally Sutton.
 - 2. Next inspection set for early December
 - 3. Hearing Panel Member-Board members to send potential names to Lisa who will reach out to see if they are interested.
 - **4.** Driveway repair criteria-John and Jim to discuss with attorney
 - **5.** Violation criteria-Will continue to focus on trash cans visible. Will look at criteria regarding air conditioners. Some of Board was concerned about citing compressors.

6. Sidewalks-Jim is looking into getting a quote for sidewalk repair. Board can then use this to make decisions about what to do moving forward.

D. Paving Committee - Terry Henry, Jim Clark

1. The Board will wait until the final vote comes in Nov. 25th before any other action is taken on paving. At meeting time the vote was 54 yes and 37 no.

1. Next annual meeting will be October 21, 2017. Please send names of speaker suggestions to Jim. Board agreed that Mike Moore should be invited back.

F. Holiday Lights Committee – Jim Beazel, Jim Clark

1. Jim bought more lights for the front. The Board members volunteered to help put the lights up on Saturday.

G. Pool Camera Committee - Kathy Clark, Kelly Cook

1. Jim wants to find a way to record by the summer and to assign individual passwords.
